**GENERAL TERMS & CONDITIONS: -**

1. Self-Attested copy of Photo ID Card (having address) i. e Aadhaar Card (UID) / Voter ID / Driving License / Passport / Govt. Issued ID Proof required at the time of booking.
2. The Booking of Theatre is neither transferable nor changeable.
3. In case the booking is cancelled due to any reason by you and the intimation or this cancellation is made before one month from the date of the function you shall be entitled to a 90% refund and 50% refund if intimation is made before 15 days from the date of the function. No refund shall be allowed if the intimation is within 15 days from the date of the function. GST will not be refunded.
4. Only residents of Purvanchal Royal City are allowed to book the Theatre
5. Food & beverage is not allowed inside the theatre. No birthday or other celebration is allowed.
6. I understand that I will be responsible for any loss or damage to the Theatre and any property stored in or belonging to the Theatre, incurred during the above times.
7. All noise levels are to be kept within reasonable limits as per the law. During the time of the use of loudspeaker, the following ambient noise levels should be maintained as per the standard specified in the notification dated 14th Feb. 2000 of Ministry of Environment & Forest, Govt. of India. DAY TIME (55 DB) NIGHT TIME (45 B (A))

8. The client agrees not to put any banners, backdrops, displays, streamers, or any electrical connection without prior permission from the Purvanchal management agrees not to drift nails and screws into permanent parts of the hotel or its properties and agrees not to smoke in the prohibited area.
9. Decoration for any occasion inside the Theatre is strictly prohibited.
10. Purvanchal Projects Pvt Ltd also reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.
11. Any damage deposit paid will normally be returned within 24 hours EXCEPT in the event of any damage to the Theatre or equipment. The extent and cost of such damage will be agreed upon as soon as possible and will be deducted from the Deposit and the balance will then be refunded. If the cost of the damage exceeds the Deposit, then the Hirer will immediately pay any balance to the Purvanchal Projects Pvt Ltd.
12. Any other damages to the Theatre properties caused will be charged according to the damage.
13. Full payment for the rent of a theatre is required at the time of booking. A booking is not considered as confirmed unless payment in full has been made. A theatre that has been booked but has not yet been paid for, maybe given away to another party if the other party makes payment before the person holding the booking.
14. The Purvanchal Management will take all necessary care but accepts no responsibility for damage or loss of merchandise left in the Theatre before, during, or after functions.
15. BAND/NAGADAS/DHOL shall not be allowed on the Theatre premises. Band to be restricted to outside the Club House.
16. Occupiers' belongings shall be preserved under their care and custody. The authority shall not be responsible for any kind of Theft/Burglary/Loss and/or any untoward situation.
17. Any damage to walls, Recliners, Soundbox Tiles, windows, furniture, fixtures, fittings, etc. will be added to the bill at the sole discretion of the management.
18. Consumption of **Alcohol/intoxicating items** and creating public nuisance is strictly prohibited. As the entire building is equipped with a fire-extinguishing plant, smoking inside the building is **strictly prohibited** to avoid any fire alarm/hazards.
19. The occupier shall ensure compliance with the above terms and conditions while booking and further to keep the walls/floors/Tiles toilets etc. neat and clean, failing which proper compensation shall have to be paid before vacating the house. Charges for any item e.g., furniture and fixtures? and/or any other articles damaged/broken while used by the occupants shall be recovered from the security.
